DOMESTIC ANIMAL ACTIVITY LIABILITY RELEASE AND ASSUMPTION OF ALL RISK

THE PROPERTY SHOP DRESSAGE & CT SCHOOLING SHOW SERIES

For and in consideration of The Property Shop at KW Partners (“Property Shop”) allowing me, the undersigned, to participate in any capacity (including as a rider, handler, longeur, lessee, owner, agent, coach, official, trainer, volunteer, or spectator) in The Property Shop Dressage & CT Schooling Show Series (including training, practices, schooling rounds, lunging, competition, and related or incidental activities): I, for myself, and on behalf of my spouse, children, heirs, next of kin, and any legal and personal representatives, executives, administrators, successors, and assigns, hereby agree to and make the following representations pursuant to this Agreement:

The undersigned is accepted for engaging in domestic animal activities, as defined by K.S.A. 60-4001, on the condition that they (or, if a minor, their guardian) fully understand and acknowledge that being around or involved with horses can be a hazardous activity – that hazards exist, including but not limited to, any and all outside influences, falls, local wildlife and insects disturbing the horse, and that kicking, biting, bucking, rearing, rolling, running, being stepped on, spooking, or other actions resulting from the unpredictable nature of the horse are common.

The undersigned hereby agrees to the provisions of this Domestic Animal Activity Liability Release and Assumption of All Risk Agreement (“Agreement”) with Property Shop as follows:

I. RULES AND REGULATIONS. The undersigned agrees to follow all instructions given or rules established by Property Shop, Maggie Stonecipher, Sarah Berkowitz, Bell Mountain Equestrian, LLC, West End Farm, Kelly Dutton, and/or any of their affiliated persons, judges, volunteers, employees, or agents, (hereafter, “Property Shop Organizers”) while attending, participating in, or observing any domestic animal activity affiliated with the Property Shop Dressage & CT Schooling Show Series.

a. **HELMET.** For safety reasons, the undersigned agrees to wear a properly fitted ASTM/SEI-approved helmet designed for equestrian activities while engaged in domestic animal activities affiliated with the Property Shop Dressage & CT Schooling Show Series. The undersigned hereby accepts full responsibility for any injuries that might occur as a result of failure to wear a properly fitted riding helmet during participation in, observation of, or proximity to any domestic animal activity affiliated with the Property Shop Dressage & CT Schooling Show Series. Property Shop Organizers reserve the right to refuse to permit the undersigned to engage in any domestic animal activity affiliated with the Property Shop Dressage & CT Schooling Show Series should the undersigned refuse to wear a properly fitted ASTM/SEI-approved helmet designed for equestrian activities while engaged in such activities. Nothing in the foregoing shall entitle the undersigned to a refund of any entry fees in the event that Property Shop Organizers refuse to permit the undersigned to engage in a domestic animal activity affiliated with the Property Shop Dressage & CT Schooling Show Series for the undersigned’s refusal to wear such helmet.

b. **CONDITION AND FIT OF TACK, EQUIPMENT, AND GEAR.** It is highly recommended for safety reasons that any tack, equipment, or gear be inspected for proper condition and fit for both rider and equine prior to participating in any domestic animal activity. The undersigned hereby accepts full responsibility for any injuries that might occur as a result of their failure to inspect the fit and condition of any tack, equipment, or gear, whether owned or provided by the undersigned, prior to participating in any domestic animal activity affiliated with the Property Shop Dressage & CT Schooling Show Series.

II. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY. In conjunction with the undersigned’s participation in the Property Shop Dressage & CT Schooling Show Series, the undersigned agrees to release, waive and covenant not to sue, and further agrees to indemnify, defend and hold harmless the following parties from any injury that might occur as a result of engaging in,

attending, participating in, or observing any domestic animal activity affiliated with the Property Shop Dressage & CT Schooling Show Series: The Property Shop at KW Partners; Maggie Stonecipher; Bell Mountain Equestrian, LLC; Sarah Berkowitz; West End Farm; Kelly Dutton; Roxanna White; the promoters, sponsors, or advertisers of the Property Shop Dressage & CT Schooling Show Series; the owners, managers, or lessors of any facility or premise where a Property Shop Dressage & CT Schooling Show Series may be held; and all directors, officers, employees, agents, contractors, and volunteers of or affiliated with any of the aforementioned parties (individually and collectively, the “Released Parties”).

- a. **COURSE AND/OR ARENA DESIGNING.** Specifically, the undersigned agrees to hold harmless the Released Parties and any of their affiliated persons, volunteers, employees, or agents for any bodily injury to the undersigned
- b. and/or an equine incurred as a result of the design, implementation, set-up, and/or use of a course and/or arena (including

but not limited to, show-jumping, dressage, and lunging area) in connection with the Property Shop Dressage & CT Schooling Show Series.

III. ASSUMPTION OF RISK. As a participant engaging in domestic animal activities in connection with the Property Shop Dressage & CT Schooling Show Series, the undersigned understands and acknowledges that they are assuming the inherent risks of domestic animal activities. The undersigned further understands and acknowledges that they have full and complete notice and understanding of the many risks inherent in domestic animal activities, which may cause, contribute to cause, or result in serious injury or even death to person or equine, or damage to property, regardless of previous training and past performance of the equine, including but not limited to, the following:

- a. The propensity of a domestic animal to behave in ways i.e., running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on, that may result in an injury, harm, or death to persons on or around them;
- b. The unpredictability of a domestic animal's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals;
- c. Certain hazards such as surface and subsurface conditions;
- d. Collisions with other domestic animals or objects; and
- e. The potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the domestic animal or not acting within such participant's ability.

IV. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE. This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements, or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

V. GOVERNING STATUTORY LAW. The undersigned has full and complete notice and understanding that this Agreement and all domestic animal activities in connection with the Property Shop Dressage & CT Schooling Show Series are governed by the K.S.A. 60-4001 *et seq.*, (the "Statutes") as they may now provide or be hereafter amended, and that the Statutes are incorporated in this Release by reference, that all terms defined by the Statutes shall have the same meaning herein, and that this Release shall be construed as to provide the Property Shop Organizers the fullest protection of a release and assumption of all risk afforded by the Statutes.
